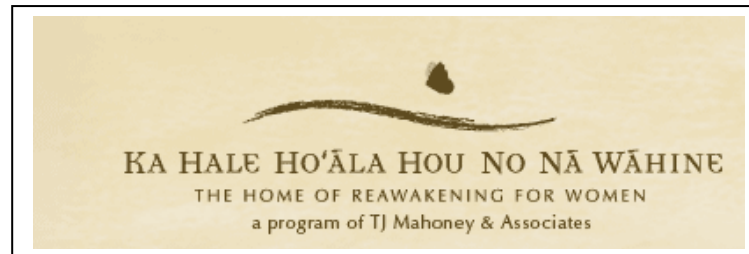

Project PROTECT is a gender specific program for pre-trial women at the Maui Community Correctional Center under the BEST (Being Empowered and Safe Together) Reintegration Program. The women are provided with case management services, classes, and other transitional services tailored to their needs while they are in pre-trial status.

Populations Served: Pre-trial women, women preparing to return to the Maui community after incarceration, women who have been convicted of a felony, and women serving at least six months in prison.

The Home of Reawakening for Women has a comprehensive program that offers a continuum of reentry services designed specifically for women. Program elements combine to create a safe and supportive residential community, skill building achieved in “real world” settings, and a gradual transition to freedom with structure and support.
Capacity: Approximately 65 women per year; 30 women at a time

Populations Served: Women who have been formerly incarcerated, women with substance abuse issues, women on work furlough, women under community custody, women on parole for a minimum of six months.

Hawaii Community Correctional Center (HCCC) is a 226-bed facility located on two sites. The primary facility is situated on three acres in downtown Hilo. Hale Nani, the facility's community reintegration program, is located five miles away in Panaewa.

In addition to its jail functions, HCCC provides reintegration programming and a work release program at Hale Nani for sentenced inmates who will be released on the island of Hawaii. HCCC also contracts with the Big Island Substance Abuse Council for a transitional community residential program in Hilo for female offenders.

Work opportunities are available through in-facility work-lines and Correctional Industries. Inmates are also able to participate in community service work-lines for county, state and not-for-profit organizations.

Kauai Community Correctional Center (KCCC) is a 130-bed facility. In addition to its jail functions, KCCC offers education, substance abuse treatment, religious counseling, cultural arts, and work furlough programs.

KCCC offers sentenced felons an opportunity to participate in its Lifetime Stand Program, which provides a structured, para-military regimen of marching, drill exercises, physical training, education, and community outreach. The Lifetime Stand Program stresses discipline, perseverance, work ethic, and personal responsibility.

In addition to in-facility work lines, KCCC community service work lines continue to provide a labor force on numerous projects for county and not-for profit organizations. KCCC's vegetable farm and fish farm are also maintained by inmates, with products used by the facility's food services unit. Excess crops and fish are donated to community organizations such as senior centers.

Maui Community Correctional Center (MCCC) is located on approximately seven acres in Wailuku. In addition to housing pre-trial detainees, MCCC provides reintegration programming to sentenced felons and parole violators who will be released on Maui.

Among the programs offered at MCCC are adult basic education, GED, parenting and cognitive skills, substance abuse treatment, vocational training, and work furlough. Extended furlough is offered in conjunction with the Maui Intake Service Center. Enables select pre-trial inmates, sentenced felons and parole violators to participate in in-facility treatment services, which is followed by another nine months of treatment in the community.

Oahu Community Correctional Center (OCCC) is the largest jail in the state and is situated on 16 acres in urban Honolulu. The 950-bed facility houses pre-trial detainees. In addition to its jail functions, OCCC also provides reintegration programming for male sentenced felons.

The pre-trial population at OCCC is offered educational, self-improvement and religious programs. The sentenced inmate population is offered programs in substance abuse, domestic violence, cognitive skills, parenting, community service work lines, work furlough and extended furlough. In addition to these programs, there are work opportunities through Correctional Industries, with the majority of jobs in light construction (i.e. office wall panel construction and installation). In an average year, OCCC employs over 400 inmates in its in-facility work-lines to provides support services for its kitchen, laundry, and other operations.

OCCC staff also oversees the Laumaka Work Furlough Center (LWFC), which is located a block away from the jail. Inmates assigned to LWFC are either actively seeking employment or working in the community. Project Bridge, which occupies one of the buildings, is the transitional program for offenders who have completed their primary substance abuse treatment.

The Halawa Correctional Facility (HCF) is made up of two separate and distinct buildings: a special needs facility and a medium security facility. The special needs facility is the old City and County Halawa Jail, originally opened in 1962 and transferred to the State in 1977. The special needs facility houses maximum and closed custody inmates, inmates with severe/chronic mental illness who cannot be placed in the general population and inmates who require protective custody.

The medium security facility opened in 1987, and is the newest and largest prison facility in the State of Hawaii. The medium security facility houses male sentenced felons.

In order to mitigate overcrowding, there are about 1,400 male inmates from HCF that are housed in out-of-state contracted facilities in Arizona

Among the programs offered at HCF are a broad range of education classes, substance abuse treatment services and sex offender treatment services. In-facility work-line positions and work opportunities are also available through Correctional Industries.

Waiawa Correctional Facility (WCF) is a 334-bed minimum-security prison for sentenced male inmates. WCF provides an environment that helps inmates successfully re-enter the community from prison. All inmates participate in education or substance abuse treatment programs.

The WCF has 240 beds devoted to KASHBOX, an intensive residential substance abuse treatment program for inmates with serious substance abuse problems. Supporting Keiki of Incarcerated Parents is a unique pilot program designed to help male inmates with substance abuse issues become better fathers. This program allows the inmate to participate in parenting groups, and structured playgroups and reading activities with their children.

The WCF also provides general education programs, which allows inmates to work towards and associate of arts degree. Also, in-facility work lines such as food service, building maintenance, heavy equipment, farm, janitorial, educational tutoring, and landscaping, help inmates acquire skills, and practice good work habits.

Women's Community Correctional Center (WCCC) is the only women's prison in Hawaii. It also serves the needs of pre-trial and sentenced female offenders. The facility houses female offenders who are of maximum, medium, and minimum custody levels.

WCCC offers a 50-bed gender responsive, substance abuse therapeutic community called Ke Alaula. Other offerings included a cognitive-based curriculum, parenting and educational classes, domestic violence treatment, day reporting, and electronic monitoring programs. Project Bridge is a program designed to assist female offenders with transitioning back to society through employment, education and substance abuse after care treatment.

In addition to in-facility programs, WCCC participates in many community service projects for state, county agencies and non-profit organizations

Mission

HOPE Resource Center (Previously known as Ponahawaiola)

Provides transitional housing services for men and women returning to our community from incarceration.

Program is staffed 24/7 and is a sober living environment. Random drug testing is conducted on site. Daily evening classes include house meetings, relapse prevention groups, gender specific groups, meth groups, new hire club, budgeting, renter's education and other life skills classes. Structure recreational activities are coordinated and offered on the weekend. Persons returning to our community have limited direction of nowhere to go and do not know what to do once they are released from incarceration. An inmate's housing plan may be denied from the supervising authority and thus have no other housing resources if not for HRC. This transitional housing program offers an alternative to continued incarceration. This program is funded by the Department of Human Services (DHS), County of Hawaii, Hawaii Island United Way and Hawaii Community Foundation.

Mentoring Program

Provides case management services to selected inmates currently incarcerated at Hale Nani Correctional Facility to provide a greater chance to success upon release and decreased recidivism. HIWEDO has sub contracted us to provide mentoring and case management services for Hale Nani inmates who are transitioning back into our community. This includes case management support, mentoring training and mentee support services. This program was made possible through a SAMHSA grant to HIWEDO (Hawaii Island Workforce Development).

Employment Resources:



Established by the Legal Action Center in 2001, the National **H**elping **I**ndividuals with criminal records **R**e-enter through **E**mployment (H.I.R.E.) Network is both a national clearinghouse for information and an advocate for policy change. It is one of several special projects at the Legal Action Center. The goal of the National H.I.R.E. Network is to increase the number and quality of job opportunities available to people with criminal records by changing public policies, employment practices and public opinion.

HIRE accomplishes these goals by providing leadership on public policy advocacy, providing technical assistance and training on overcoming labor market barriers based on a criminal record, and promoting collaboration between individuals directly affected by the criminal justice system, advocates, practitioners, researchers, and policymakers working to improve the employability of people with criminal records.

- Potential employers looking for incentives to hire individuals with criminal histories;
- Service providers and individuals with criminal histories who are looking for assistance in finding employment; and
- Researchers and policy makers looking at current programs to ascertain what programs are effective and serve their intended purpose.

Federal Bonding Program

The Federal Bonding Program provides fidelity bonding insurance coverage to individuals with criminal histories and other high-risk job applicants who are qualified, but fail to get jobs because regular commercial bonding is denied due to their backgrounds.

Tax Credits

The Work Opportunity Tax Credit (WOTC) is a federal tax credit to reduce the federal tax liability of private for-profit employers to be used as an incentive for employers to hire individuals from eight different targeted groups: TANF recipients, veterans, ex-felons, high risk youth, summer youth, Food Stamp recipients, SSI recipients, and vocational rehabilitation referrals.

Unemployment Insurance Office

Unemployment compensation is a social insurance program designed to provide benefits to most individuals out of work, generally through no fault of their own, for periods between jobs. In order to be eligible for benefits, jobless workers must demonstrate that they have worked, usually measured by amount of wages and/or weeks of work, and must be able and available for work.

The unemployment compensation program is based upon federal law, but administered by states under state law. One can file a new claim for unemployment insurance benefits or reopen an existing claim by calling the telephone filing system, Hawaii Tele-Claim, at 808-643-5555.

Criminal Record Repository

This is the agency individuals may contact to obtain a copy of their state rap sheet. The criminal record repository can also tell the individual who else is legally entitled to have access to his or her record.

Conviction data may be accessed on Public Access computers at the Data Center, the main county police departments, and the Kona Police Department on Monday through Friday from 8:00 a.m. to 4:30 p.m. To search the conviction database, the subject's name, social security number, sex, and birth date are needed. A printed copy of a Public Access search costs \$10. If some of the personal identification information for the subject to be checked is unknown, the Data Center will conduct a name-based check for \$15. The Data Center will conduct a fingerprint-based access and review request (for the individual) for \$25.

The Bobby Benson Center is non-profit, private corporation with a mission to “free youth in Hawaii from chemical dependency and co-occurring disorders through residential treatment services employing best practices for youth and their families.” The center has fee-for-service contracts with the Department of Health (Child and adolescents Mental Health Division), and the State of Hawaii Judiciary (Client Services). Our facility also participates with all major health insurances plans.

Program expectations at the Bobby Benson Center help youth-at-risk to achieve a clean and sober lifestyle, good mental health, educational services, addiction recovery, and clinical treatment (both psychological and psychiatric). The treatment program is fully accredited by the Hawaii State Health Dept., and the Commission for Accreditation of Rehabilitative Facilities (CARF).

The Bobby Benson Center admits teens between the ages of 13 and 17 who are suffering from alcohol or drug dependence. Dual-diagnosed clients are eligible for treatment at the Center when psychiatrically stable. Eighteen- year-old clients are considered for admission if they are developmentally more suited for treatment with adolescents than with adults. **Treatment services and preference for admission is given to pregnant women and intravenous drug users. condition.

Positive Outcomes Sustaining Successful Education (O’AHU) – promotes positive development for at-risk youth attending the Hawai‘i National Guard Youth Challenge Academy.

Voluntary Case Management (O’AHU & HAWAI‘I ISLAND) – assessment, case planning, crisis intervention, and visitation services for families with children who are at risk of being abused or neglected.
